

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.facilityservicesinc.com](http://www.facilityservicesinc.com) and Facility Services Management, Inc. and governs data collection and usage. ### **Collection of your Personal Information**
